I undertake to be bound by the rules issued by the FMSSL now and in the future and to any Supplementary Regulations which apply. I further certify that I am medically fit to take part in motorsport events.

I certify that the information / enclosures submitted with the application form, to the best of my knowledge and belief, true, complete and correct in every particular. I agree that any Competition License issued is the exclusive property of the FMSSL. Only the FMSSL, as the National Motorcycle Sports Federation of the Government of Sri Lanka, has the power to grant or withdraw it and to settle any disputes that may arise from its use. By signing this form, I certify that I, shall not participate in any event not authorized by the FMSSL with this license. Finally, I hereby acknowledge that I am fully conversant with the risk and dangers of motor sports in general which I assume hereby.

I DO HEREBY FURTHER AGREE TO THE FOLLOWINGS

- 1. I will not participate in any motorcycle sporting event which has not obtained FMSSL approval.
- In case of an event out of Democratic Socialist Republic of Sri Lanka I will participate only with the written approval of FMSSL
- 3. I will not use my competition license issued by *FMSSL other than for any FMSSL approved meets.
- 4. I will not sabotage or arouse any others to sabotage event organized under the approval of *FMSSL
- 5. I will not bring disrepute to "FMSSL or its affiliated clubs

Failure to obey any of the above FMSSL has all rights to cancel or suspend the competition license and take any disciplinary action against me
